In addition, special budget approved clean-up projects have been completed at the Bridge on Redding Ridge and the cart path starting at Stonington. Watch for more improvements to the planting areas at the pool entrance. As Stoney Brook plantings mature, more hedges, shrubs and trees will need replacement or severe pruning to keep plantings in proportion to the size of the buildings at the Club House and throughout the subdivision.

Our grounds maintenance manager, pool and clubhouse manager, and our treasurer are working regularly to carry out their duties. The Secretary is also hard at work reminding us of what our 2012 goals are.

#### **Revised Clubhouse Deposit Now Required**

The Board has enacted a \$100 refundable cleaning fee for reserving the clubhouse. We've added additional garbage bins and a recyclable bin. We hope this will ensure the clubhouse gets cleaned thoroughly after it is used so it is ready for the next neighbor. Keeping the clubhouse clean helps maintain its value to the HOA. Reminder - the agreement requires the home owner's signature to ensure the home owner will be present throughout the event. Read it carefully before signing. Remember - no wet swimsuits in the Club House.

## **Tree Removal**

If you want to cut down trees, you must get approval from SBHA's ACC before you can get a City permit to do so. But, don't stop there, trunks are trees too. They should be removed or ground down and covered with mulch or pinestraw.

# New Pool Keys, Pool Rule Reminders and ACC Standard Reminders

In mid-July the keys to the pool gate and rest room doors will change. Work is in progress to make this procedure as pain free as possible.

One key will be issued at no charge to each household and will have to be signed for by the legal owner or official renter. When you sign for your key, you will also be attesting you have copies of the pool regulations and SBHA Covenants. If you lose your key during the season, a replacement key can be requested for \$10.

Your Board apologizes for any inconvenience this may cause. Unfortunately, the majority of SBHA owners who follow the rules have to conform to this security issue because there are a few residents and non-residents who do not have privileges at Stoney Brook facilities, but continue to use them. Remember, only legal residents of Stoney Brook who are in good standing (dues paid up to date) and their guests can use common areas.

Board members and their designated assistants (such as pool staff) have the Board's full support in enforcing common area rules and standards. If someone questions you about something you are doing that may not be in accordance with SBHA, please try to settle any dispute amicably.

Major Pool Reminders:

- Sign in.
- Guests must be accompanied by the resident.
- Rough Play and Profanity are Banned.

- THERE IS NO LIFEGUARD ON DUTY! Please read the rules posted at the pool regarding your personal responsibility.
- No wheeled devices or carts are allowed in the pool area or on the sidewalk leading to the pool. Please park them in the parking lot.
- No animals in the pool area.
- No wet bathing suits in the Club House.
- There is limited (but very nice) pool furniture available. PLEASE share it.
